

Revision of Axis Bank **PRIORITY** Debit Card Terms and Conditions

Following revisions will be applicable to your Axis Bank **PRIORITY** Debit Card:

1. Domestic airport lounge program

- Get 2 complimentary domestic airport lounge access per quarter
- Lounge access benefits will be based on debit card spends. To access complimentary lounge, minimum spends required will be INR 5,000 over the previous 3 calendar months.
- In case of a newly issued Debit Card, the minimum spend criteria is waived for the month of issuance followed by the next 3 calendar months (as illustrated below)

2. International airport lounge program

- Get 2 complimentary lounge access for cardholder and accompanying guests per year at select airport lounges outside of India
- The total complimentary visits are applicable for both cardholder and guests. The cardholder should be present with the guest to avail the complimentary visit.
- Please note, in line with RBI regulations, international transactions are not enabled on NRO Debit Cards. Therefore, none of the mentioned benefits are applicable to NRO Debit Cards. However, these benefits can be availed using eligible NRE Debit Cards.

3. Movie Offer

- 25% discount up to INR350 (whichever is lesser) on movie ticket
- The movie offer can be availed in a single transaction only

4. EDGE REWARDS Points

- **Offer:**
 - 2 **EDGE REWARD** Points on domestic transactions for every Rs. 200 spent
 - 3 **EDGE REWARD** Points on international transactions for every Rs. 200 spent
- Transactions done with **PRIORITY** Debit Card towards below select categories will not be eligible for **EDGE REWARD** Points.

5. Card product limits

- Daily ATM limit of INR 1 Lakh and Purchase limit of INR 7 Lakhs
- If ATM and/or Purchase limit of the debit card exceeds the maximum product limit, it will be adjusted to the new limits: ATM – INR 1 Lakh and Purchase – INR 7 Lakhs.

6. Fees & Charges

- Replacement Fee: Replacement fee is charged towards customer's Debit Card for each replacement card issued due to damage, loss, or theft etc.
- A cross-currency mark-up of 3.5% + GST will be levied for all international cash withdrawal and purchase transactions.
- Dynamic Currency Conversion (DCC): This is a service offered at international points of sale or ECOM the transaction is converted to your home currency at the time of purchase. A fee of 1% of the transaction amount, plus applicable Goods and Services Tax (GST), will be charged.
